# 3.2 Action

>Motion 023 - Action on Expulsion Hearing 2023/24-01- Rebecca Sloan motioned 3.2.1 to expel the student from the Yreka Union High School District for violation of California Education Code Section 48900.4: "Intentionally engaged in harassment, threats, or intimidation, directed against a pupil or group of pupils, that is sufficiently severe or pervasive to have the actual and reasonably expected effect of materially disrupting classwork, creating substantial disorder, and invading the rights of that pupil or group of pupil by creating an intimidating or hostile education environment....." for the current semester and spring semester of 2023/2024. During the period of expulsion, the student is to be given the option of participation in the YUHSD Community Day School. The Board further requires the student to complete 30 units of coursework each semester during the expulsion, attend school a minimum of 90% during the expulsion period, complete 30 hours of community service, and participate in a counseling program focusing on Social Emotional. During the period of the expulsion, the student is not allowed to attend any school activities, nor be on campus of any other program unless they are so directed and accompanied by a school official. The student has the option to appear before the Board at the end of the current semester to discuss the possibility of returning to Yreka High School campus for the next semester. The student is directed to appear before the Board of Trustees during the regular June board meeting, in closed session, report on their progress, and request readmission to the district The motion was seconded Keith Callison and unanimously carried.
